# Promulgating Manual of Standard - Aeronautical Telecommunications -Volume IV - Surveillance and Collision Avoidance Systems

## **DECIDES:**

Article 1. Issued together with this Decision the Manual of Standard -Aeronautical Telecommunications - Volume IV - Surveillance and Collision Avoidance Systems (*details are in the attached appendix*).

Article 2. This Decision comes into force from 15<sup>th</sup> September 2023 and annuls the section relating to the recognition and application of Annex 10 of ICAO in Decision No. 1805/QD-CHK dated 14<sup>th</sup> August 2019 of CAAV on recognition and application of ICAO Annexes on Air Navigation Services (ANS).

Article 3. Director General of Viet Nam Air Traffice Management Corporation, Airports Corporation of Viet Nam; Director of Air Navigation Department, Heads of relevant agencies and organizations are responsible to execute this Decision./.
